ARE YOU CONSIDERING A SELF DETERMINED PROJECT? OR...

WONDERING HOW TO COMPLETE THE APPLICATION / PROPOSAL??

WELL, READ ON....

FIRST OFF YOU SHOULD READ PUBLICATION #5005 – “SELF DETERMINED PROJECT REGULATIONS” AND DECIDE WHICH UNIT OF THIS PROJECT SUITS YOU (i.e., Unit I / II or III).

NOW, LOOK AT ITEM 3. (B) .. IT SAYS....

PLAN – DEVELOP A 100 – 200 WORD WRITTEN OUTLINE OF YOUR PROJECT AND SUBMIT IT TO THE PROJECT LEADER AND THE YOUTH DEVELOPMENT STAFF PERSON FOR APPROVAL PRIOR TO STARTING THE PROJECT.

YOUR OUTLINE WHICH IS YOUR APPLICATION / PROPOSAL, SHOULD HAVE THE FOLLOWING INFORMATION

ASK YOURSELF THESE QUESTIONS ABOUT YOUR PROJECT TOPIC WHEN COMPLETING YOUR APPLICATION / PROPOSAL...

WHAT IS THE PROJECT YOU HAVE DECIDED ON?

2ND WHAT DO YOU PERSONALLY HOPE TO LEARN FORM THIS PROJECT?... AND...

3RD WHAT DO YOU PLAN TO SHARE WITH YOUR CLUB AND DISTRICT ABOUT YOUR SELF DETERMINED PROJECT?

WHY DID YOU CHOOSE THIS PROJECT?

HOW DO YOU INTEND TO COMPLETE THIS PROJECT?

(think about your month to month activities and agenda in working towards a completed project.... i.e., what is it you will be doing with your project monthly?)

WHEN DO YOU PLAN ON STARTING AND WHEN DO YOU PLAN ON BEING FINISHED?

(note: Unit I & II have a 4 – 6 month time requirement and Unit III has a 10 – 12 month requirement)

PUBLICATION #5000 – “A GUIDE TO SELF DETERMINED PROJECTS” – PAGES 9 – 14 GIVE YOU SOME GOOD IDEAS ON THE “WHAT / WHY / HOW / WHEN” QUESTIONS.
